## COMPETITION ETIQUETTE FOR ATHLETES AND SPECTATORS

To help all those involved in the sport of twirling here are some guidelines for coaches, athletes and parents to keep in mind at competitions.

1. Our volunteers work hard to run competitions. Please allow them the time to set up in the morning by respecting the “door opening time” stated in the brochure.
2. Most facilities do not allow food or drinks in the gym. When this rule is ignored trash and spills can create a loss of use of that facility. Please be aware of any trash you create and clean it up before you leave.
3. Many of us are excited to see our children involved in a competition. Flash photography is strictly forbidden in the gym. It can cause an athlete to be distracted or blinded temporarily, creating a dangerous situation. Your cameras are welcome but please use high speed films or video cameras that do not require additional lighting.
4. Keep in mind that the gym floor is for athletes only. Please enter and exit the gym in between sets, walking outside the performance floor, after a team or individual has left the floor and before the announcer gives the “music” cue to the performers. Remember, parents may be trying to watch their child perform!
5. Please keep your child safe by knowing where they are and how they are behaving. Running on the gym floor, under or through the bleachers is an accident waiting to happen.
6. Athletes please respect the practice times on the floor. The announcer will let you know when the floor is open for practice of a particular event, such as dance twirl. If you are not in that event you should not be on the floor.
7. Keep your conversations quiet. Our children deserve our respect when they are on the floor showing us how hard they have prepared for this moment.
8. Be a cheerleader! Children thrive on positive attention and all team and individual performers deserve your applause.

Directions From Annapolis: Rt. 2 south, turn right on 214 (W. Central Ave). Approx 1.5 miles down road on left.

From Washington, D.C.: 50 East to Davidsonville Rd. (Exit 16, Rt. 424). Take right and continue south on Davidsonville Rd. Approx 3.5 miles, at light, left on 214 (W. Central Ave). Approx 1.5 miles on the right.

From Baltimore: 97 South, take the MD-665 exit toward Aris T. Allen Blvd/Riva Rd. Keep right to take Exit 22 toward Riva Rd. Make a right onto Riva Rd. South. Left on 214 (Central Ave). Riva Trace is 0.1 miles on right.

### **Tasker Middle School**

**Bowie, Maryland**

From Baltimore Beltway South on Rt. 3 about 20 miles to Rt. 197. Right on 197. About two miles, turn right at light onto Kenhill Drive. School on corner of 197 and Kenhill. From DC Beltway: Take Rt 50 exit (19A, 50E, Annapolis) to Bowie exit 11 (Rt 197, Collington Road). Bear to left. Take 197 N and turn right at light onto Kenhill Drive. School on corner.

### **Parkdale High School**

**6001 Good Luck Road, Riverdale, Maryland**

Route 495 to Kenilworth Avenue (Route 201 South) towards Bladensburg. Go approximately 2 miles, make a left onto Good Luck Road. Go approximately ¼ mile, school is located on right (in valley)

**THE ROBERT V. SETERA SCHOLARSHIP COMPETITION** is held annually. Scholarship award is given to an athlete 14 years of age or older, who exhibits positive qualities such as character and sportsmanship, dedication to the sport of baton twirling, community service, and academic achievement. Athletes must be nominated by their coach. Nomination forms available on our website and at the parent liaison table at each contest. Nominations should be sent to Terry Stewart, 13202 11<sup>th</sup> St., Bowie, MD 20715 or by email to [TSTwirl@aol.com](mailto:TSTwirl@aol.com). Deadline is listed on the nomination form. Presentation of Scholarship Awards will be at the beginning of the Scholarship contest. All nominees must be present before the contest begins. Any questions, please call Terry 301-805-2204.

**PACE EVALUATIONS** Proficiency Accomplishment for Championship Events. The present USTA rules that determine the method by which an athlete progresses through the levels from novice to elite is based on the number of competitive first places won rather than the actual twirling skills the athlete has achieved. PACE is a non-competitive event which provides an opportunity for athletes to perform in the competition setting at his or her level. Participation level is determined by his/her recent scores in the official USTA events. Level I - scores up to 3.79, Level II - scores 3.80-4.59, Level III- scores 4.60-5.79, Level IV- scores 5.80-6.99, Level V- scores 7.00-8.99. Athletes receive a critique tape, comment sheet, score, and ribbon for their performance. Athletes are not ranked for placement. Please specify 1 ½ minute or 2 minute Solo music on the entry form. Only one PACE evaluation per event.

**SCHOLASTIC TWIRL TEAM:** Unsanctioned. Team must be associated with a school. Team uses their own music. Performance time is 3-4 minutes with a 10 second leeway. Small and Large team categories: Sm 4-8 members; Lg 9+ members. Junior and Senior Divisions offered: Jr :13-15 average age. Sr Division: 16+ average age. Athlete's age is the age they will be on their birthday in this calendar year: January 1-December 31. This is an unsanctioned event. Team must have USTA membership or pay member for a day fee for each athlete. Prop restrictions: More than one baton per athlete is allowed. Other props (ribbons, flags, swords, knives, fire batons, etc.) may not be used.

**POM and DANCE TEAMS:** Unsanctioned. Team uses their own music. Performance time has no minimum. Tiny Tot and Primary maximum 2 minutes. Juv, Jr, and Sr divisions maximum 3 minutes. Small and Large team categories: Sm 4-8 members; Lg 9+ members. Age divisions same as Dance Twirl Teams. Athlete's age is the age they will be on their birthday in this calendar year: January 1-December 31. Team must have USTA membership or pay member for a day fee for each athlete. Pom teams may not use any props other than poms. Gloves or hats that are not removed during any part of the routine are not considered props. Dance teams do have option of using any props, except poms. Poms are not permitted for Dance Teams. Tap shoes and hard soled shoes are not permitted. Content Restrictions: No basket tosses, half tosses, tosses of any kind, lifts, pyramids, stuntbuilding, knee drops, split drops, front drops, mounts, partner stunting, or any move where the weight of one individual is completely supported by one or more other individuals. This includes standing on or stepping on backs, upper legs, lifts, mounts, or similar moves. These restrictions are put in place for the safety of the athletes. Violation of these content restrictions will result in a 25 point penalty for the team. Full guidelines available at the parent liaison table or by request to Terry Stewart.

**Trios Team Event:** Unsanctioned event will consist of three athletes twirling together. Trios will provide music of their choice following the USTA Dance Twirl time limits of 2-3 minutes and will be held during the team portion of the competition. Judging will follow USTA Dance Twirl team guidelines. There will be one level of competition (no beg/interm/adv). There will be Tot, Primary, Juvenile, Junior, and Senior divisions following the age rules of USTA dance twirl and twirl teams. Trios wishing to compete in multiple age divisions must have a 33% change in athletes (1 member). Awards will follow the awards in the dance twirl team category.

## General Contest Information for Council Contests:

### *Special Notes and USTA Rules:*

- Twirl Teams and Dance Twirl Teams who choose to compete in both categories **MUST** compete with different routines and must utilize completely different song/music selections. Song selections must be listed on entry form. Violation will result in disqualification by Contest Director.
- Age requirement for freestyle critiques will match the USTA Pre-Trials and Trials guidelines.
- One compulsory or movement technique evaluation is given at no fee for those who enter freestyle critique.
- As of 9/1/06 USTA limits athletes to 2 levels of compulsories and/or Movement Technique at any meet.

**ENTRY FORMS** are in reverse order starting from *back* of booklet. *All team entries can be put on one sheet.*

**USTA RULES** will be used for USTA sanctioned competitions. If you have questions with regards to USTA rules and regulations, please see Parent Liaison table at any Maryland Council competition or contact any MBC representative.

**NO SHOWS** will be not be refunded any fees.

**MAKE CHECK PAYABLE TO** MARYLAND BATON COUNCIL for council contests. Other contests, make check payable to sponsoring organization. See entry form for more info. Returned checks will be assessed a \$25 fee and must be paid in full prior to the child or team being allowed to participate in any event.

**USTA MEMBERSHIPS** Membership number should be included on entry form. Membership payment must be mailed directly to USTA. Membership will be checked via internet on entry deadline date. If you are not listed, you must pay **MEMBER FOR A DAY** fee (\$8 / athlete) or you will not be allowed to compete. Member for a Day available for local, State, and Regional competitions.

**GROUP FEES** \$3 per member (Large team cap of \$45); Facility Fee/Tape Fee/USTA Surcharge have been combined for organizations. Fee is \$10 per team entered to be paid with entry.

**AWARDS**                      **Team:** 1<sup>st</sup> and 2<sup>nd</sup> place.                      **Individual:** 1<sup>st</sup> through 3<sup>rd</sup> place.

**GROUP AGES** Average age. Prim 9 and under, Juv 10-12, Jr 13-15, Sr 16 and over, Tiny Tots actual twirling age of all team members 7 and under. Age of twirlers count, not aux. members. *Athlete's twirling age is the age they will be on their birthday in this calendar year: January 1-December 31.*

**GROUP AND INDIVIDUAL DIVISIONS** *Novice:* Never won a competitive first place. *Beginner:* less than 5 competitive 1st places at any level; *Intermediate:* less than 10 at any level; *Advanced* has won 10 or more competitive 1st places at any level. OTHER ORGANIZATION WINS DO COUNT. If intermediate level is not offered, athlete must enter advanced after 5 competitive wins.)

**SET SYSTEM** Must twirl "ON NUMBER" - MISS TURN, NO TWIRL.

**COMPULSORIES** CAS evaluations must be recorded in an Achievement Book and signed by a certified judge. Athlete must have proof of passing all prior levels. Without proper documentation, evaluations must be re-done.

**CONDUCT** *ANYONE CONDUCTING THEMSELVES IN AN UNSPORTSMANLIKE MANNER OR DAMAGING THE SCHOOL WILL BE DISMISSED FROM THE SCHOOL WITHOUT REFUND AT DISCRETION OF CONTEST DIRECTOR.*

**FOOTWEAR** No hard-soled shoes or boots on gym floor.

**NO FLASH PHOTOGRAPHY OR VIDEO LIGHTING during any portion of the contest !!!**

**DOOR OPENING TIME** Our volunteers work hard to run competitions. Please allow them the time to set up in the morning by respecting the "door opening time" stated on the entry forms.

**NO FOOD OR DRINK IN GYM** Most facilities do not allow food or drinks in the gym.

- SHOW CORPS:** Jr / Sr. Class A / Open. 8 or more twirling members. 4-6 min
- PARADE CORPS:** Nov(unsanctioned) / A Class / Open Class. 8+ twirlers. Juv(unsanctioned) / Jr / Sr. Time: 2-3 min. (10 sec leeway) MAY NOT PASS IN REVIEW - 2 pt penalty. Fwd progression 1:30 min. Recorded or Live Music.
- TWIRL TEAMS:** Own music. Sm 4-8 members; Lg 9+ members. 3-4 min. (10 sec leeway) Prim / Juv / Jr / Sr. Beg / Int / Adv
- DANCE TWIRL TEAMS:** Same as Twirl Team except for time: 2-3 min. (10 sec leeway)
- TINY TOT DANCE TW:** Own music. ACTUAL TWIRLING AGE OF EACH MEMBER MUST BE 7 OR UNDER. 2-3 min.  
Sm 4-8 members; Lg 9+ members. Beg / Int.
- TRIOS TEAMS :** Own music. Three twirling members. 2-3 min. (10 sec leeway) Tot / Prim / Juv / Jr / Sr. (Unsanctioned)
- SCHOLASTIC TWIRL TEAM:** Team associated with a school. Own music. Entrance / exit your choice. Sm 4-8 ,members;  
Lg 9+ members. 3-4 min. (10 sec. leeway) Jr / Sr. (Unsanctioned) Prop restrictions: More than one baton per athlete is allowed. Other props (ribbons, flags, swords, knives, fire batons, etc.) may not be used
- POM TEAMS:** Own music. Sm 4-8 members; Lg 9+ members. Tot / Prim- Max 2 min. Juv / Jr / Sr- Max 3 min. (Unsanctioned)
- DANCE TEAMS:** Own music. Sm 4-8 members; Lg 9+ members. Tot / Prim- Max 2 min. Juv / Jr / Sr- Max 3 min. (Unsanctioned)
- PERCUSSION ENSEMBLE:** Any type percussion instrument. Juv / Jr / Sr division: 2-5 minutes. (Unsanctioned)
- COLOR GUARD:** Jr / Sr. 8+ members. (Unsanctioned)
- AVERAGE AGES OF TEAMS:** Prim: 0-9; Juv: 10-12; Jr: 13-15; Sr: 16+. Tiny Tot: twirling ages of all members 7 and under. Each group will have the option of competing in an older age division than that of the average age, if there is at least one member whose age is within that higher age division. A 25% personnel change is required to enter additional age divisions.

- PACE EVALUATIONS:** Proficiency Accomplishment in Championship Events. Evaluation only. Include last score received.
- SPORTSWEAR MODEL:** Age Divisions: 0-6, 7-8, 9-12, 13-16, 17+. NO BATON. Open pattern. Time 1 min max w/ 5 sec leeway. (Unsanctioned)
- DRESS/GOWN MODEL:** Same as sportswear modeling. (Unsanctioned)
- BEST APPEARING:** Ages same as modeling. T-Pattern. 1 min. timed music w/ 5 sec leeway. Poses with baton. (Unsanctioned)
- BASIC STRUT:** Age Divisions: 0-6, 7-8, 9-12, 13-16, 17+. 32 count square. Nov / Beg / Int / Adv. USTA Basic/Military Strut Music.
- MILITARY STRUT:** Ages same as Basic. 32 counts. Retraced L-Pattern. Nov / Beg / Int / Adv. USTA Basic/Military Strut Music.
- BODY FORMS:** Ages same as Basic. 32 counts. Free floor pattern. No gymnastics, illusions. Baton use limited to loops and passes only.  
C, B, B1, BII: Level determined by lower classification in Compulsories and Movement Tech. USTA Presentation Music.
- PRESENTATION:** Ages same as Basic. 32 counts. Free floor pattern. Finish with acknowledgment last 4 counts. Nov / Beg / Int / Adv.  
USTA Presentation Music.
- RHYTHM TWIRL:** Ages same as Basic. 64 counts. Free floor pattern. Baton use limited to contact material, including flips for C & B level.  
No gymnastics or illusions. C, B, B1, BII, A, AA, AAA: Level determined by lower classification in Comp and Move Tech.  
USTA Rhythm Twirl Music.
- STANDARD SOLO:** Evaluative Event. Prescribed routine. Comments address drops, breaks, deviations from original choreography, improper placement of baton, or body alignment. Performed to 1 ½ minute USTA Solo Music.
- SOLO:** Primary: 0-8, Juvenile: 9-12, Junior: 13-16, Senior: 17-20, Adult: 21+. Nov / Beg / Int / Adv. Open & Instate.  
Time: Nov / Beg / Int: 1-1/2 min; Adv : 2 min. Music: USTA Solo
- DANCE TWIRL SOLO:** Ages same as Solo. Music: USTA Dance Twirl
- 2-BATON:** Age divisions as needed. 1-1/2 min. Beg / Int / Adv. Open and Instate. USTA Solo music.
