Circle "T" Modeling: 1:00 minute maximum (Nov, Beg, Adv);

Super X: Nov, 0:30–2:00, Beg, Int, Adv, 1:30–2:00 offered for Open, Instate, Visitor's, Elite.

Solo: Nov 0:30–2:00, Beg: 1:30–2:00, Int: 1:50–2:10, Adv: 2:20–2:30, offered for Open, Instate, Visitor's, Elite and Mens.

College Solo: One baton must be twirled for a minimum of 1:10 minutes. Second half if desired may include multiple batons and novelty batons. No props allowed (2 point penalty);

Two Baton: Nov: 0:30–2:00, Beg, Int, Adv: 1:30–2:00,

Three Baton: Beg & Adv: 0:30–2:00

Duet/Pairs: Novice, Beginner, Intermediate, Advanced:

Time same as solo divisions, Ages: 0-18, 19-24, 31-50, 50 +

Rhythmic Twirl: Beg & Adv: 2:00–2:30 (timing begins and ends with first and last note of music).

**** Rating Lane** (Super "X", Solo, College Solo). You receive comments only, no awards. Must compete first in appropriate level offered.

**** Contestants are responsible for reporting to lanes on time. Miss turn no performance.**

**** No flash photography. Video taping (own child, own student).**

**** 3-Part and Twirl-off score sheets will be distributed after awards ceremony. All score sheets for posted events winners will be at awards table. All other score sheets will be distributed in an alphabetized manner using boxes (similar to A.Y.O.P.).**

Directions: **

From North: Take I95 South toward Washington, stay on I95 South Follow signs toward the direction to College Park. Take Exit #25B (Route 1 South toward College Park-University of Maryland.) Once on Route 1 South follow it for 5.1 miles (last big intersection will be Route 1 and East/West Highway). Continue on Route 1 to Madison Street. Turn right onto Madison Street follow to large parking lots. Gymnasium on right.

From South: Take I95 North toward Baltimore. Continue on I95 to Exit 2B (Route 1 South toward College Park-University of Maryland.) Once on Route 1 South follow it for 5.1 miles (last big intersection will be Route 1 and East/West Highway). Continue on Route 1 to Madison Street. Turn right onto Madison Street follow to large parking lots. Gymnasium on right.

From West/Frederick: Take Route 270 South to the exit for Route 495 toward Silver Spring. Continue on route 495 until it turns into Route I95 South. Follow I95 to Exit 25B (Route 1 South toward College Park-University of Maryland.) Once on Route 1 South follow it for 5.1 miles (last big intersection will be Route 1 and East/West Highway). Continue on Route 1 to Madison Street. Turn right onto Madison Street follow to large parking lots. Gymnasium on right.
